## Your Green Belt still NEEDS YOU!

# We're fundraising and we need your support...

It's been over a year since Elmbridge Borough
Council (EBC) consulted residents on its Strategic
Options for a new Local Plan. In this consultation, the
Council's suggested 'Option 2' proposed to declassify
three areas of 'weakly performing' Green Belt to allow
for large scale housing developments.

Our local Green Belt was one of these three areas ('Area 58'). Its classification as 'weakly performing' seems to be solely based on a questionable report, in which the area was misrepresented. The evidence used for this report included a photograph of the hockey club car park. There was no sign of the open green space used by our community (Stokes Field/One Tree Hill), with its beautiful views, the Buddhist retreat or the recreational facilities of the allotments, cricket and hockey clubs.

Whilst little has been publicised since the consultation, we are concerned that the threat to our Green Belt has not gone away. We need to raise funds, urgently, protect it and we need your help.



#### Who we are

The 'Save HWLD Green Belt' team (formerly the HWLD Action Group) are a group of residents from Long Ditton and Hinchley Wood, who are passionate about maintaining and protecting our valuable Green Belt land and community spaces. We support the provision of more housing, in a responsible and sensitive way, for the wellbeing of current and future generations.

#### The story so <u>far</u>

FEB 2017 Consultation results showed that 91% of those who replied (across Elmbridge) oppose Option 2. MAR 2017 Taylor Wimpey became the Freehold owner of a parcel of land which includes the Rose Nursery and the area known locally as One Tree Hill/Stokes Field Hill as far down as the track bordering the nature reserve.

# SEPT 2017 EBC leafleted residents asking for their preferences on its priorities going forward:

On the environment, the top response from residents, is 'to preserve green spaces' (74%).
In the next 5 years, residents want EBC to be known for 'protecting the Green Belt'.

**DEC 17 The London Plan was published for consultation.**In it, the Mayor, says he will build all the housing it needs within its boundaries, and will not need to build on Green Belt (redefined as Green Infrastructure) to do so.

FEB 2018 In their draft response to the Mayor's London Plan, EBC encouraged the Mayor to review Green Belt. Under pressure from bodies, including the Long Ditton Residents' Association, this was removed. It is a concern that EBC do not seem to be listening to the residents' Consultation feedback.

Throughout the last year or so, our team has met with key figures including Dominic Raab MP, senior executives at EBC, contacts at Surrey County Council and professional planning consultants to encourage a strategic approach to meeting the Government housing quota demands.

## Why would it be irresponsible to offer up Green Belt in Elmbridge?

- The Green Belt within the M25 is already fragmented, and is performing its main purpose well.
- It sets a precedent.
- Green spaces are good for health and wellbeing, and counter the impact of pollution. This will become even more important given the potential impacts of the London Plan (development of Kingston/ Tolworth), Heathrow expansion and Crossrail 2.

## What can we do to protect our valuable piece of Green Belt?

Last August our team helped contact local residents to ask them to complete questionnaires supporting a 'Village Green' application for Stokes Field/One Tree Hill. A large number of evidence forms were lodged with Surrey County Council, we will need many more...

## Our Village Green

In Summer 2017, an application was made for Village Green status on the open space within our Green Belt used widely by our community – One Tree Hill/Stokes Field and Nature Reserve.

Village Green status would be a recognition of the community value of this land, and would protect it for future generations.

Note that a 'Village Green' is *not* an archetypal piece of lush grass used for village fetes. It is an area of land that has been used freely by a significant number of people for 20+ years for a variety of pastimes. Exactly what this area is.

Much research was done, with expert guidance, to establish that Stokes Field/One Tree Hill has a valid case to become a Village Green. The application was submitted, with supporting evidence from a large number of local residents in August.

#### What next?

Despite the research and expert guidance, a hurdle has been raised by EBC arguing that the Village Green application is not valid. However, legal advice has been obtained that argues against this, stating that this is an incorrect interpretation of the law.

#### How can you help?

If the Village Green application is successful, **Stokes Field/One Tree Hill can be saved**, allowing future generations to enjoy this open green space at the heart of our community.
